APPEAL TO YOUR HIGH OFFICE, FOR THE DISQUALIFICATION OF MR. GODFRED DAME ALSO KNOWN AS MR. GODFRED YEBOAH DAME AS THE NEWLY APPOINTED ATTORNEY GENERAL AND MINISTER OF JUSTICE OF THE REPUBLIC OF GHANA.

My name is Freda Darko, a citizen of the Republic of Ghana, the Chief Executive Officer of Freko FD Enterprise Limited and Express 2020 Company Limited.

Mr. Chairman, I respectfully write to your office for the disqualification of Mr Godfred Dame as the newly appointed Attorney General and Minister of Justice by the President, his Excellency Nana Addo Dankwah Akuffo Addo, due to his deliberate actions which continues to infringe on my fundamental human rights.

Mr. Chairman, respectively; about 21 years ago, I purchased a parcel of land at Clinton Street, Shiashe, named as plot 187, 188 and 189, also known as 10, 12 and 13. Mr Godfred Dame used the law firm of the President of Ghana, Akuffo Addo Prempeh and Co, with his client Mrs Comfort Korkor Kwashie, and took my former husband Joseph Manu to court; and secured judgement on the 2nd day of July 2009, before his Lordship N.M. C Abodakpi J to take part of the land I was in possession and have legal documents of ownership, which is plot 189, also known as 13, which he said was in boundary with plot 12.

The court gave Judgement in their favour and awarded general damage for trespass assessed at 50,000.00 GH cedis, and cost of 2,000.00 GH cedis, was awarded in favour of the plaintiff.

The Judgment of the court is attached (marked as **'Exhibit FD1'**).

My former husband Joseph Manu, filed a motion on notice to set aside execution, dated 14/10/2010, because bailiffs of the court carried out a wrongful execution with the intention to attach two other plots which were not subject matter of the suit, namely plots no.187 and 188, also known as plot 10 and 12.

The court on the 2nd Day of November 2010, made an order to set aside the wrongful execution carried out by the bailiffs of the court on the 14/10/2010. The motion on notice to set aside the execution on the 14/10/2010, and the order of the court dated the 2nd day of Day of November 2010, by his Lordship Mr N.M.C Abodakpi J are attached; presented as **'Exhibit FD2 and Exhibit FD3'**.

Mr Chairman to my utmost surprise, Mr Godfred Dame and his client Mrs Comfort Korkor Kwashie, filed a motion on notice application for review, of the order of the court dated 2nd day of November 2010, averred that the land in respect of which execution was carried out was one piece of land and not three different plots of land, and he brought affidavit to the court which was sworn by Mrs comfort korkor kwashie's attorney, Nene kwarshie and was signed by her son Sam kwashie. in their affidavit, and with the intention to take the other part of the land, He changed the boundary of plot 13 in boundary with plot 12, and said plot 13 was bounded on the North and West by plots of land numbered "10" and "11", so his client is the owner of the three plots.

Mr Chairman, respectfully, if someone's plot is in boundary with another plot, does it mean the person is the owner of the plot he shares boundary with? This shows how vicious Mr Godfred Yeboah Dame is.

The court dismissed the application on the 21st day of January 2011, and said the land is three separate plots. To buttress my point, I have attached a copy of the **Review application motion** and marked as **'Exhibit FD4' Notice of filling of documents which he filed on the 8th day of February 2008 which has documents from Lands Commission proving that the land is three different**

plots is attached and named as 'Exhibit FD5', The ruling by the court dated 21st day of January 2011, is attached and marked as 'Exhibit FD6'.

Mr. Chairman, Mr Godfred Dame managed to secure an order to garnishee my accounts, to retrieve money which was awarded to his client in a suit I was not a party to. I am still in shock as to where and how he managed to get my accounts details. This shows how vicious he is.

Mr Chairman, I have attached the writ of summons issued on the 16th day of November 2007, and the entry of Judgment filed on the 11th day of December 2009 by Godfred Dame to prove that I am not a party to the case, and I have marked them as **Exhibit FD7**.

My former husband, Joseph Manu, filed a motion on notice to stay execution of further execution for my accounts to be discharged on the 27th October 2010, and served Mr Godfred Dame through his clerk Eric, which constituted proper service on 2nd November 2010 at 4:11pm.

On the 11th Day of November 2010, the court granted the motion to stay further execution and my accounts, which were wrongfully attached by Godfred Dame, were discharged.

I have attached the order made by his Lordship Mr. N.M.C Abodakpi J, on the 11th Day of November 2010, and marked as '**Exhibit FD8**'.

Mr Chairman, I am factually right to say that Mr. Godfred Dame, does not deserve to be the Attorney General and Minister of Justice of our Country. A person who uses unlawful means to take someone's property and money cannot lead the public as the Attorney general and Minister of Justice.

Mr. Chairman, also, I have an ongoing case at the Land Court 12, Greater Accra Region presided over his Lordship Justice Amos Wuntah Wni J, with the case titled **FAL 569/13 Freda Darko Vrs Comfort Korkor Kwashie and 4 others**.

Mr Chairman, the Deputy Attorney General and Minister of Justice Mr. Godfred Dame, for the records is the Counsel for the parties I have sued. My question is, how can a Deputy Attorney General and Minister of Justice be a counsel for an individual?

In conclusion, per the above discussion, I cry on your high office as the Appointments Committee Chairman of Parliament to disqualify the appointment of Mr. Godfred Dame as the Attorney General and Minister of Justice of the Republic of Ghana. Because a person who finds ways which is contrary to the laws of our dear country to cheat a fellow citizen does not deserve the position as the Attorney General of our dear country, Ghana.
