The proposal emphasizes the need for more balanced regional development within the context of a National Development Plan; greater allocation of royalty revenues to resource rich communities; the need for jobs training; and development of alternative livelihoods including agriculture, agro-processing, and tourism.

The proposal is the result of a Petition that the Galamsey Action Group started on Change.org to request that the Ghana Government take action to "Stop galamsey devastation in Rural Ghana" to save Ghana's rivers and land. The Petition generated over 9,500 signatures as of June 19, 2021!

The Galamsey Action Group (GAG) is a group of Ghanaians located in Ghana and abroad, including professionals with varied knowledge, skills and experience who are genuinely concerned about the level of devastation caused by galamsey and irresponsible mining in Ghana.
